State Superfund Site Delist Notice

The Inactive Hazardous Waste Disposal Site Program (the State Superfund Program) is the State's program for identifying, investigating, and cleaning up sites where the disposal of hazardous waste may present a threat to public health and/or the environment. The New York State Department of Environmental Conservation (DEC) maintains a list of these sites in the Registry of Inactive Hazardous Waste Disposal Sites (Registry). DEC has determined that this site ([see map on reverse side](#)) no longer presents a threat to public health or the environment and is proposing to delist the site from the Registry for the following reason(s):

- Remedial action at the site included the excavation of approximately 62,000 cubic yards of miscellaneous waste and contaminated soil, the removal of approximately 7,000 drums, and supplying public water to residents adjacent the site;
- Subsequent monitoring of groundwater demonstrated that contaminant concentrations had attenuated to levels approaching groundwater standards and most recent sampling (2018) confirmed that only low levels of contamination remain; and
- The site is subject to the Alcoa site-wide deed restriction, which restricts the use of the site to industrial uses.

Public comments are being received before the decision to remove the site from the Registry is finalized. The public comment period will end November 6, 2020. A summary of any comments will be assembled and made available for viewing at our Regional Office.

If we do not receive any new or additional information during this public comment period that changes our delist proposal, we will delist the site on or after December 6, 2020.



